I warrant that I have entered into the releases and waivers contained in this Agreement voluntarily and that I make them without any duress or undue influence of any nature by any person.

PARENTS CODE OF CONDUCT
LaVerkin City Sports Program

As a Participant in the LaVerkin City Sports Program, I have read the following code of conduct for Parents:

1. I will remember that an important part of my child playing sports is his or her enjoyment, not mine.
2. I will encourage my child to play by the rules and to resolve conflict without resorting to hostility or violence.
3. I will support and encourage the concept of my child belonging to a team and I recognize the benefits of the commitment, discipline and the social skills learned and acquired.
4. I will not ridicule or yell at my child for making a mistake or losing a game.
5. I will not be critical of or embarrass any player, including opposition players.
6. I will remember that children learn by example. I will applaud good plays by both my child's team and their opponents.
7. I will support the concept of "zero tolerance" and will not yell or question an official's judgment. I recognize that officials are being developed in the same manner as players.
8. I will refrain from use of abusive or vulgar language at the field or any youth sporting functions.
9. I will not throw objects of any kind on the field.
10. I will insist that my child plays in a safe and healthy environment that is free of alcohol, drugs or tobacco and I will refrain from their use at all youth sporting events.
11. I will not yell, taunt, threaten or inflict physical violence upon any player, coach, official or spectator at any youth sporting activity.
12. I respect and understand that the coaches and parents that assist in running the LaVerkin City sports program are volunteers who are helping to make my child's experience enjoyable.
13. I acknowledge my responsibility to report infractions that I observe to the LaVerkin City Parks and Recreation Director.
